¹APR, projected monthly payments, and total cost of loan examples are based on a \$10,000 loan disbursed in one disbursement with either 5-year, 10-year, 15-year or 20-year repayment. APR's provided include a 0.25 percent interest rate reduction for authorizing our loan servicer to automatically deduct your payments each month from your bank account. The interest rate reduction for authorizing our servicer to automatically deduct monthly payments from a savings or checking account will not reduce the monthly payment, but will reduce the monthly finance charge, resulting in a lower total cost of loan. Variable APR rates may increase or decrease depending on fluctuations in the London Interbank Offered Rate (LIBOR) index. Monthly interest rate accrual is based on the published One-Month London Interbank Offered Rate ("LIBOR") as of the last business day of the previous month plus your applicable margin. As of October 31, 2017 the One-Month LIBOR rate is 1.24%.

²Autopay Benefit: During periods when payments are due, you will be eligible to receive a 0.25 percentage point interest rate reduction on your loan by authorizing our loan servicer to automatically deduct your payments each month from your bank account. The interest rate reduction for authorizing our servicer to automatically deduct monthly payments from a savings or checking account will not reduce the monthly payment, but will reduce the monthly finance charge, resulting in a lower total cost of loan.

³Cosigner Release allowed if an account is in current standing, after 36 months of consecutive and on-time payments with a borrower FICO >699 and minimum income requirement of \$30,000 for loan balances up to \$100,000, and income requirement of \$50,000 for loan balances over \$100,000 with no foreclosures, repossessions, wage garnishments, unpaid judgments or other public records having an open balance exceeding \$100 during the last 7 years. Borrowers must also have a debt-to-income ratio of 43% or less and not currently be involved in bankruptcy proceeding or had any bankruptcy filings during the past 10 years and cannot have any defaults on education loans.
